## INTERNATIONAL PRIVATE EQUITY VALUATION BOARD ANNOUNCES THE ENDORSEMENT OF FOUR NEW ASSOCIATIONS

The International Private Equity Valuation (IPEV) Board today announced that four new associations have endorsed the International Private Equity and Venture Capital Valuation Guidelines developed by AFIC, BVCA and EVCA.<sup>1</sup>

- The Swedish Venture Capital Association (SVCA)

With a total of 31 endorsing associations worldwide, excluding the three founding associations EVCA, BVCA and AFIC, the International Private Equity and Venture Capital Valuation Guidelines have proven to be well perceived globally.
